Lowe's Wong has a thriving Music Tuition tradition with over 150 pupils enjoying lessons each week. We currently use the services of Inspire through a contract with Notts. County and Paul Dawn Guitar to deliver our instrumental and voice lessons. All teachers in the scheme are qualified, experienced and are subject to a DBS check (in possession of an Enhanced CRB Certificate).

**Lesson Fees & Invoicing:**

Single Lesson (based upon two students sharing a 20-minute session)	£82.00 per term
Individual Lesson (based upon one student for 20 minutes)	£162.00 per term
Instrumental loan (where available)	£23.00 per term

Please be aware that prices may increase due to adjustments made by Inspire.

Lessons are charged as a package price for each term. This is based on receiving a minimum of 10 weekly lessons per term.

The school invoices termly in advance for all other instruments and voice lessons, via your account with [www.eduspot.co.uk](http://www.eduspot.co.uk). Please ensure all invoices are paid promptly in order for students to remain on the timetable. Failure to pay an invoice will result in no further time being ordered and the application process would have to be repeated to begin lessons again at the earliest opportunity.

**Cessation of Lessons:**

In order to cease instrumental and voice tuition, **notice MUST be given in writing prior to the deadlines** detailed below. - Students that are a looked after child

## Terms and Conditions for lessons provided by Inspire

1. All accounts are submitted termly and are payable in advance. If one term's payment is missed lessons will be suspended until full payment is received.
2. Cost is based on a 20-minute shared lesson in a group of 2. Individual lessons are available, upon request, at an additional cost. Lessons will be charged as a package price for each term. This is based on a maximum of 12 weekly lessons with a minimum 10 weekly lessons per term.
3. If you wish to cease your child's lessons for the coming term, we will only accept written notice of the intention to stop lessons provided it is received by the dates advertised. Failure to do so will result in you being liable for the next term's fees.
4. Notice to cease music lessons can be made any time before the advertised due date and should be sent to [vbaxter@lwj.org.uk](mailto:vbaxter@lwj.org.uk) or confirmed in writing to the School Office. The due date is usually six weeks prior to the commencement of the new term.
5. Should Inspire no longer be able to fulfil their commitment to provide music tuition, we reserve the right to cancel lessons offered under the current scheme. In this instance parents would be given one month's notice and fees adjusted accordingly.
6. Fees are subject to revision and written notification will be given of any alteration.
7. Any lessons missed due to tutor absence will be refunded to the original form of payment, unless the invoice remains outstanding when you shall receive a credit to either the current or occasionally the next term's bill. Lessons will only be refunded if the total number of lessons that term fall below the minimum quantity of 10.
8. There will be no refunds for lessons missed due to pupil absence (including field trips) except for an extended illness/injury of more than three weeks. Where possible staff will do their best to rearrange these lessons if reasonable notice is given.
9. Pupils in Years 3 and 4 will not usually be permitted to undertake tuition in more than one instrument (including voice). Pupils in Years 5 and 6 who wish to have tuition in a second instrument/voice may do so at the discretion of the school and music tutors.
10. To ensure all young people can access a full range of opportunities, a remission scheme is available and those eligible are:
  - Students who are eligible for free school meals
  - Parents who are in receipt of the NHS exemption certificate (we will require a copy of the current NHS exemption certificate every year)

### **Third Party Terms and Conditions for lessons provided by Paul Dawn Guitar**

1. All accounts are submitted termly directly from Paul Dawn and are payable within 14 days of the invoice date. If one terms payment is missed, lessons will be suspended until full payment is received.
2. Cost is based on a 20minute shared lesson in a group of 2. Individual lessons are available, upon request, at an additional cost. Lessons will be charged as a package price for each term. This is based on a maximum of 11 weekly lessons with a minimum 10 weekly lessons per term.
3. If you wish to cease guitar tuition for the coming term, we will only accept written notice of the intention to stop lessons provided it is received by the dates advertised. Failure to do so will result in you being liable for the next terms fees.
4. Notice to cease guitar tuition can be made any time before the advertised due date and should either be confirmed in writing to the school office marked for the attention of Paul Dawn or emailed directly to [pauldawnuitar@hotmail.co.uk](mailto:pauldawnuitar@hotmail.co.uk) The due date is usually 6 weeks prior to the commencement of the new term.
5. Fees are subject to revision and written notification will be given of any alteration.
6. The cost of any lessons missed due to tutor absence will be taken off the invoice for the next term if the absence means less than 10 lessons will be received that term.
7. There will be no refunds for lessons missed due to pupil absence (including field trips) except for an extended illness/injury or more than 3 weeks. Where possible I will do my best to rearrange these lessons if reasonable notice is given.
8. To ensure all young people can access a full range of opportunities, a limited remission scheme is available and those eligible are:
  - Students who are eligible for free school meals
  - Parents who are in receipt of the NHS exemption certificate (we will require a copy of the current NHS exemption certificate every year)
  - Parents who are in receipt of Universal Credit – monthly take home pay is lower than £935 (confirmation is required)
  - Students that are a looked after child

Places for students wishing to apply for the Remission are available on a first come, first served basis as there are limited places available. Remission students will receive a weekly shared lesson and the hire of a guitar. Lessons are subject to satisfactory behaviour, effort, regular practise and care of hired guitar.
